

**ENKELEJDA HAVARI** is a Research Fellow at the European Commission, Joint Research Centre (Ispra, Italy). She is part of the Competence Centre on Microeconomic Evaluation\_(CC-ME), Unit I.1 - Modelling, Indicators & Impact Evaluation. Before joining the Commission in 2015, she was a Visiting Scholar and Lecturer at Boston University where she taught courses on empirical economics. From 2012 to 2014 she was a post-doctoral researcher at the University of Ca' Foscari Venice. She holds a Ph.D. in Econometrics and Empirical Economics (University of

Rome II) and a Master's Degree in Economics (University of Bologna). She has given several lectures and held training sessions on evaluation for both researchers and policy makers and makes extensive use of counterfactual evaluation tools in her research. Her main interests lie in the area of applied microeconometrics and impact evaluation with a special focus on labour economics, economics of education and family economics.
